Job Title: National Consultant to develop the capacities of the Civil Protection and Emergency Situations

Service, the Republic of Moldova in Project Management on Disaster Risk Management

Project Reference: Moldova Disaster and Climate Risk Reduction Project

Duration of Employment: June 15 – November 30, 2015

Contract type: Individual Contract

BACKGROUND

Moldova's economy, population, and environment are highly exposed and vulnerable to climate variability and change and different kinds of natural hazards, including drought, floods, severe weather, earthquakes, and landslides. Average annual losses from hydrometeorological hazards comprise around three percent of GDP (if the 2007 drought is factored into the annual average). They have a severe impact upon the rural population of Moldova, which makes up around 60% of the total and depends largely upon agriculture for their livelihood. Overall annual losses from geophysical hazards account for 0.9% of GDP. These primarily threaten infrastructure, homes, and public buildings.

The Moldova Disaster and Climate Risk Reduction Project, Phase II, is a 3 year project (October 2013 – September 2016), funded and implemented by UNDP. During the first phase of the project a gradual shift of focus from traditional disaster response towards a more comprehensive approach to Disaster and Climate Risk Management oriented at prevention and preparedness could be observed. Building on this, the second phase will put emphasis on developing disaster risk management capacities, raising awareness of the general population and policy- and decision makers and increasing the level of knowledge of practitioners.

The main objective of the 2nd phase of the project is to reduce disaster and climate risks in Moldova through the development of national and local risk management capacities. Outputs in support of this objective are as follows:

- Coordination, planning, and monitoring capacities enhanced to execute the National Disaster Risk Management Strategy
- 2. Key stakeholders and society have improved DRR awareness and knowledge, as well as strengthened ability to develop own capacity
- 3. Regional and Local level risk management replicated and upscaled in Moldova

The main implementing partners of the Project are the Civil Protection and Emergency Situations Service of the Ministry of Interior and its affiliated training centers, Ministry of Environment, Ministry of Health, Crisis Medicine Training Center, Ministry of Education, LPAs, NGOs and CBOs. According to National Action Plan for the implementation of the RM-EU Association Agreement 2014 - 2016 Civil Protection should develop and further approve the Methodology of disaster risk assessment with subsequent application at all levels. In order to strengthen the capacities of the Civil Protection and Emergency Situation Service, the Ministry of Interior, the Republic of Moldova UNDP is searching for a qualified International Consultant to develop capacities of the Civil Protection and Emergency Situations Service, the Republic of Moldova in Project Management and Disaster Risk management together with the International consultant.

OBJECTIVES AND SCOPE OF THE ASSIGMENT

The Overall objective of the assignment is to support the International Consultant in developing the capacities of the Civil Protection and Emergency Situations Service (CPESS) in disaster risk management and risk assessment and to develop capacities of the CPESS in efficient Project Management.

The National Consultant will assist the International Consultant in conducting two missions (up to 5 days each) in Moldova. He/she will develop and conduct 2 training modules (3 days each) on Project Proposal Writing and Project Implementation for a selected group of trainees. She/he is also supposed to Additionally the National Consultant will be providing coaching and mentoring for the group of trainees in the process of development of 2-3 project proposals to various donors in the area of Disaster Risk Management and Risk Assessment.

It is expected that the Consultant will:

- 1. Support the International Consultant in performing a quick needs assessment for developing capacities in Disaster Risk Management and Risk Assessment in close cooperation with Civil Protection and Emergency Situation Service and UNDP Moldova.
- 2. Support the International Consultant in conducting two three-days trainings in Moldova for a one group of national stakeholders in Disaster Risk Management and Risk Assessment (International Consultant will elaborate curricula and training materials).
- 3. Develop curricula and training packages for a set of two trainings (3-days each) on Project Management and Proposal Writing for a group of selected trainees from Civil Protection and Emergency Situations Service, Ministry of Interior.
- 4. Conduct two tree-days trainings for a group of selected trainees from Civil Protection and Emergency Situations Service on Project Management and Proposal Writing. Trainings should be participatory and include practical exercises. Participants should get presentations, case studies, reference documents, links to useful resources and other supportive materials based on the best national and international experiences. Provide coaching and mentoring to support the participants in the elaboration 2-3 project proposals (for EU and non-EU funds).
- 5. Prepare a work schedule, reports and submit them to UNDP and Civil Protection and Emergency Situations Service of the Ministry of Interior (CPESS).
- 1) Support the International Consultant in performing a quick needs assessment for developing capacities in Disaster Risk Management and Risk Assessment in close cooperation with Civil Protection and Emergency Situation Service and UNDP Moldova.
 - a) Review, discuss with stakeholders and incorporate the recommendations into the methodological approach and plan for the quick needs assessment elaborated by the International Consultant.
 - b) Support the International Consultant in performing the quick needs assessment that should be done in close collaboration with the Civil Protection and Emergency Situation Service and UNDP Moldova.
- 2) <u>Support the International Consultant in conducting two three-days trainings in Moldova for a one group of national stakeholders in Disaster Risk Management and Risk Assessment.</u>
 - a) Support the organization of trainings and conduct together with the International Consultant two trainings (three days each) on Disaster Risk Management and Risk Assessment with the participants from the Civil Protection and Emergency Situations Service and other national stakeholders. Support trainings' evaluation
 - b) Prepare together with the International Consultant training reports.

- 3) <u>Develop curricula and training packages for a set of two trainings (3-days each) on Project Management and Proposal Writing for a group of selected trainees from Civil Protection and Emergency Situations Service, Ministry of Interior.</u>
 - a) Develop curricula on Project Management and Proposal Writing for a group of selected trainees from Civil Protection and Emergency Situation Service, national stakeholders involved in the Disaster Risk Management. Two trainings (3 days each) should be organized.
 - b) Develop the training packages on Project Management and Proposal Writing for approved curricula. The training packages shall include, but shall not be limited to: agenda, teaching methods, case studies, handouts and other materials as necessary.
- 4) <u>Conduct two three-days trainings and coaching for a group of selected trainees from Civil Protection</u> and Emergency Situations Service on Project Management and Proposal Writing.
 - a) Prepare and conduct two trainings (for days each) on Project Management and Proposal Writing for the group of selected trainees from the Civil Protection and Emergency Situations Service.
 - b) Provide coaching and mentoring for the trainees in developing 2-3 project proposals (for EU and non-EU Donors) on disaster risk management and risk assessment.
 - c) Prepare training and coaching reports.
- 5) <u>Prepare a work schedule, reports and submit them to UNDP and Civil Protection and Emergency</u> Situations Service of the Ministry of Interior (CPESS)
 - a) Prepare a work schedule and detailed methodological approach for the implementation of the assignment.
 - b) Prepare training reports, and coaching report.
 - c) By the end of assignment, prepare final report on accomplished work, lessons learned, and recommendations for further implementation and next steps to be taken.

- Proven experience on preparation of written reports in an accurate and concise manner, and public presentation skills.
- Good working knowledge of English is required for this assignment.
