#### Terms of references

**Job Title:** National Consultant for development of the Environmental Integrated Information System Concept

Project Reference: Mainstreaming biodiversity conservation into Moldova territorial planning policies

and land-use practices

# I. Background

The United Nations Development Programme (UNDP), acting as an implementing agency of the Global Environment Facility (GEF), is providing assistance to the Ministry of Environment of the Republic of Moldova in implementation of the GEF Medium Sized Project (MSP) "Mainstreaming Biodiversity Conservation into Moldova's Territorial Planning Policies and Land-Use Practices" (BD mainstreaming project).

Despite the Government's reform efforts, the spatial/territorial planning framework is facing two types of barriers: (i) inadequate planning and enforcement framework and (ii) inadequate demonstrated experiences in spatial planning and biodiversity-compatible land management practices.

Against this background, the BD mainstreaming Project will be addressing the gaps in land planning and enforcement systems through development of relevant regulations, standards and legislation to accommodate biodiversity conservation objectives while the gap of limited coordination across sectors will be addressed by establishing a multi-stakeholder committee which will ensure a unified approach in the development, implementation and enforcement of land-use plans from the different ministries and departments. In addition, a monitoring system will be emplaced among the various regulatory agencies, assigning responsibilities based on comparative advantage, in order to evaluate acceptable limits of change in biodiversity-important areas. The gap of inadequate demonstrated experiences in spatial planning and biodiversity-compatible land management practices will be tackled through development and testing of biodiversity-compatible district spatial (land-use) plans in 2 districts of Moldova, relying on cross-sectoral working groups, GIS technologies for biodiversity mapping, identification of sites of conflict between biodiversity and human activities and others.

Overall, the objective of the project is to mainstream biodiversity conservation priorities into Moldova's territorial planning policies and land-use practices through two components – the first will focus on modifying the land use planning and enforcement system so that it addresses biodiversity loss, and the second will demonstrate methods for conservation and sustainable use of biodiversity on communal lands outside PAs.

The BD mainstreaming project is implemented as part of a larger biodiversity programme, which includes also UNDP/EU Clima East Project "Sustainable management of pastures and community forests in Moldova's first National Park Orhei to demonstrate climate change mitigation and adaptation benefits and dividends for local communities".

## II. Scope of work and responsibilities

The United Nations Development Programme in Moldova, through its Project "Mainstreaming biodiversity conservation into Moldova territorial planning policies and land-use practices" is seeking to contract a national consultant, who will provide necessary conceptual and practical support in development of the Environmental Integrated Information System Concept of the Ministry of Environment.

## **Expected tasks**

The key tasks of the consultant are as follows:

# Development of Environmental Integrated Information System Concept (EIIS) up to 150 working days

The Environmental Strategy for the years 2014-2023 and the Action Plan for its implementation foresees the development of the Environmental Integrated Information System Concept according to the Government system and grants the access to this system for the interested public; the deadline for implementation is 2017. EIIS Concept should be developed in accordance with the Government approved technical document ("Procesele ciclului de viaţă al software-ului" RT 38370656 - 002:2006) developed by the Ministry of Information Technology and Communication and taking into account specific requirements from the E-Governance centre. The EIIS Concept will also build on the findings of the ICT audit of the Ministry of Environment, which will be carried out in the same period of time. The EIIS Concept should include the following activities:

# Development phase up to 120 working days

- Analyzing the legal and normative framework of the system;
- Inspection of the organizational structure to ensure the proper management of the system;
- Establishment of the documentation package for the EIIS;
- Assessment of IT level of the proposed EIIS;
- Establishment of the system's functions;
- Identification of the components of the informational objects, its identifiers, beneficiaries, scenarious and attributes;
- Identification of the information flow, its circulation and the problems for integration with other systems;
- Identification of the mechanisms and the persons in charge for system management;
- Development of proposals in order to update the legal and normative framework (as the need arises-development new projects of normative and legal acts), modifying the organizational structure and/or establishing new structures, setting up the new documents and/or ammendments for the existing documents;
- Establishment of the proposals regarding the technological structure of the system, as well the information security problems;
- Development of the draft concept of the EIIS;
- Present the draft concept during the validation workshop with key stakeholders;
- Based on the comments received finalize all the documents for official coordination.

#### Consultation phase up to 30 working days

- Support the Ministry of Environment during the official consultation process through participation at round tables, meetings, etc;
- Support the Ministry of Environment in development of the final concept of the EIIS and all supporting documents ready for Government approval.

The consultant will work closely with the Working group created in the framework of the Ministry of Environment and will coordinate the work of the monthly working group meetings.

## III. DELIVERABLES, ESTIMATED WORKLOAD AND TIMEFRAME:

The assignment should be carried out within the period of August 2016 – December 2017, not exceeding 150 working days.
