A. BACKGROUND

The overall objective of the project is to encourage confidence building in ATU Gagauzia and Taraclia district, including neighbouring communities, through improved rural development opportunities leading to enhanced competitiveness of the agro-food sector, promotion of local entrepreneurship, creation of jobs, and raising incomes. The project has the following components:

- 1: Enhanced Dialogue and Community Empowerment;
- 2: Local entrepreneurship and SMEs development;
- 3: Small-Scale Infrastructure Refurbishment and Promotion of Inter-Municipal Cooperation.

The project will be implemented in line with the confidence building approach, connecting region's authorities and structures to the national ones, facilitating dialogue and inclusion in development of national strategies, as well as connecting neighboring villages/small towns through inter municipal (territorial) cooperation.

The intervention supports the implementation of national development priorities, while responding to challenges of European Union driven reform. It is built on the priorities of the Government Programme 2015-2018, the National Development Strategy Moldova 2020, the National Agriculture and Rural Development strategy, the National Decentralization Strategy 2012-2015, the United Nations Partnership Framework (for 2013-2017), Moldova 2020, Strategy for SMEs development 2020, National Regional Development Strategy 2014-2020, National Strategy on Water Supply and Sanitation and National Waste Management Strategy.

Specific background

Moldova has recently made important steps in establishing and strengthening the strategic management mechanisms and tools at the national and regional level. The Government designed the country development strategy, "Moldova 2020," set up the Medium Term Budgetary Framework, and established the framework for regional development policies and sectoral policies. The strategy on agriculture and rural development for the period of 2014-2020 have been developed and approved in June 2014. The Regional Development Council of Gagauzia was established in October, 2015. However, there is a lack of strategic development vision of the regions for the period 2016-2020. The Socio-Economic Development Strategy (SEDS) of Gagauzia for the period 2017-2022 in the process of development.

Hence, based on the needs, and considering the importance for the overall development of the region, support for the development of the new Strategy for Socio-Economic Development (SEDS) of ATU Gagauzia initiated. A model of inter-sectorial cooperation, aimed for at national level, will be

piloted at the Gagauzian autonomy level, contributing to a comprehensive and holistic approach towards rural development and agriculture.

The EU-funded "Support to Agriculture and Rural Development (SARD)" project implemented by UNDP hired the Institute for Development and Social Initiatives (IDIS) "Viitorul" (IDIS) to support ATU Gagauzia to develop socio-economic development strategy in an integrated manner that will help the ATU GAGAUZIA to prioritize its actions and establish a development path for its region in correlation and in context with the national strategies of Republic of Moldova. The development strategy will be used by the local public authorities as a real public policy instrument in solving problems at the region level and will ensure its sustainable development in the long term perspective based on established SMART measures, outcomes and other indicators.

Given the above mentioned, the SARD project seeks an International Consultant who will assist the IDIS with the peer-review of drafted SEDS of ATU Gagauzia.

B. SCOPE OF WORK

The overall objective of the assignment is to provide substantive expert consultancy and peerreviewing of the draft Socio-Economic Development Strategy of ATU Gagauzia and the Action Plan for 2017-2022 (hereinafter SEDS) designed by the Institute for Development and Social Initiatives (IDIS) "Viitorul" (IDIS) in line with regional development strategy and international standards.

The international technical consultant in strategic planning will evaluate and provide recommendations for the socio-economic development strategy's goals, objectives, and corresponding performance measures. This may require analysis and facilitation of focus groups/workshops/roundtables to ensure that the plan meets region's expected requirements and opportunities.

The main objective of this assignment for the International Consultant (hereinafter Consultant) is to:

- i) Support the IDIS in formulating a coherent, well-structured, analytical and fine-tuned policy document by proving advanced peer-review of the drafted SEDS;
- ii) Provide recommendations for improvement of the per-final drafted SEDS and proposed action plan
- iii) Peer-review the final version of the draft document of SEDS;

C. TASKS AND ESTIMATED WORKLOAD

The assignment will require the completion of the following tasks:

- Previous experience in development assistance or related work for a donor organization, consulting company, or NGO.
