Job Content

I. BACKGROUND

The EU4Moldova: focal regions Programme (further Programme) is based on the European Commission Implementing Decision on the Annual Action Programme 2018 in favor of the Republic of Moldova and is funded by the European Union and implemented by the United Nations Development Programme.

The overall objective of the five-year Programme is to strengthen the economic, territorial and social cohesion in the Republic of Moldova through facilitating smart, inclusive, sustainable and integrated socio-economic development as well as improving the standards of living of the citizens in the focal regions: Cahul and Ungheni.

To this end, this Programme will address also the urban-rural divide and regional disparities, stimulate economic growth and job creation, refurbish and upgrade some social and technical infrastructure in selected areas (smaller towns and villages) while taking into account climate change and a gender perspective in all the activities of the Programme.

Specific objectives:

- 1. To strengthen transparency, accountability of local public authorities and people's participation in local governance processes in the focal regions.
- 2. To improve citizens' access to quality public services and utilities in the focal regions.
- 3. To create employment opportunities for men, women and youth in the focal regions and improve the attractiveness of the focal regions for investors and entrepreneurs.
- 4. To promote the smart specialization of the economy of the focal regions through the development of the clustering and value chain approach in key economic sectors.

The Programme objectives will be achieved through measures targeted at: (i) capacity building to support the implementation and monitoring of local economic development plans; (ii) civil society engagement in local planning, governance processes and basic social service delivery; (iii) provision of investment funding in support of the creation and/or development of social and technical infrastructure which, combined with the outcomes from interventions (i) and (ii) above, will have an immediate, visible and tangible impact on employment creation, the standard of living of the population in the focal regions.



II. SCOPE OF WORK

The **overall objective** of the International Consultant on Low Carbon Economic Development (LCED) assignment (hereinafter Consultant) is to provide methodological guidance and technical expertise in road-mapping of the Programme interventions for supporting 2 focal regions from the Republic of Moldova to build their competitiveness in promoting green and climate resilient economic growth and job creation. In this regard, the Expert is expected to deliver the **following activities**:

- Support the Programme to undertake the preparatory activities for defining the 'functional economic area' and initiation of the LCED field interventions in two focal regions;
- Support the process of elaboration of Low Carbon Economic Development Roadmaps for two focal regions with the environmental and climate change considerations duly mainstreamed:
- Support the conceptualization of the methodological approach to facilitate and catalyze the implementation of LCED Roadmaps in two focal regions.

Note: The term of 'focal region' is used to define the broader area of Cahul municipality (35 thousand inhabitants) and Ungheni municipality (32 thousand inhabitants), comprising adjacent rural communities (to be further defined).

IV. INSTITUTIONAL ARRANGEMENTS

This is a home-based assignment with 3 missions to Moldova (Chisinau). Visits to Moldova are to be coordinated prior and approved by the Programme Manager. The International Consultant will be provided with a work space in Programme's office. In-country transportation, logistics and interpretation (if needed) will be provided by the Programme and, therefore, shall not be included in the consolidated financial offer. The International Consultant has to cover on its own the airfare and accommodation during assignments in Moldova and, thus, shall be included in the consolidated financial offer. Documents for review and evaluation will be provided by the Programme in electronic format. All the above-listed deliverables shall be endorsed by the Programme Manager within 14 calendar days from their submission.

The Consultant will work in a team, along with other local and national consultants, and support them based on a comprehensive tailor-made methodology, which should be determined at the inception of activities.

The Consultant is expected to undertake three in-country missions (up to 50 working days in total):

- At least 5 years of international experience in the field of local economic development;
- Advanced experience related to implementing PACA² (Participatory Appraisal of Competitive Advantage) methodology (at least 2 projects/assignments);
- Advanced experience in conducting Rapid Economic Appraisal processes;
- At least 3 years experience in the field of low carbon economic development;
- Experience in European/East-European countries in the area of assignment will be an advantage;
- Experience in facilitation, coaching, mentoring and/or delivering trainings in the field of local economic development;
