1. SHORT INTRODUCTION ON RFP PURPOSE

Purpose:

- Selection of one company to provide Information and Communication Technology (ICT) services for the development of the Small Arms and Light Weapons e-Register Information System;
- Main objective of the project is to increase State capacity over arms and munitions control, as well as improve crime investigation capacity.

2. Os & As

Question: Could you please clarify that the equipment you are referring to is our recommendation for the

hardware that will be used at building the information and telecommunication infrastructure of SALW. Please also clarify if we must include in our offer similar recommendation for software

infrastructure.

Answer: Companies participating in the competition must indicate the required hardware for a

successful implementation and functioning of the system. The price of the equipment shall not be included in the financial offer. The equipment will be purchased within a separate tender. The companies *must include similar recommendation for software infrastructure, also.*

Question: Please provide us more information regarding the strict type of scheme of the information

infrastructure of the electronic communication of the State AIS. Please also explain what State

AIS means.

Answer: The technical offer shall comply with the terms of reference; all the requirements will be

stated in the technical specifications developed by the winning company.

Question: Could you please specify if the system will be part of e-Governance. Will it be integrated within

cloud computing?

Answer: Yes

Ouestion: Where will the servers be located?

Answer: The servers will be located within the Special Telecommunication Center server room.

Question: Please clarify if the presentation of the proof of application for license in "Service provision in

cryptographic protection of information" issuance is sufficient.

Question: Will the company be eliminated from the competition if does not have such a license? Please

clarify the need for this license.

Answer: Yes. This requirement is enforced by the legislation, namely:

- the system entry data are personal data and according to pt. 55 of the **Government Decision nr. 1123 from 14.12.2010 on Requirements for the assurance of personal data security at their processing within the information systems of personal data all methods of remote access to personal data information system will be secured (using VPN,**

encryption, ciphering, etc.), and shall be documented, monitored and controlled.

The Terms of Reference clearly state that the winning company will set up a VPN security network for system interaction and connectivity and will provide services to protect transmitted information. For provision of services in cryptographic and technical protection of the information (except activities held by public authorities empowered with this right by law) license is required.

Failure to comply with the rules on transmission of personal data will lead to the inability to develop the regulation system to be coordinated with the Protection of Personal Data Center.

Question: Please clarify if a user database already exists or it will be developed.

Answer: The user database will be created. It is estimated that the user database will not exceed 100

entries.

Question: Please provide us more information regarding the information security assurance.

Answer: SALW e-register information system has to be developed inline with the requirements of

Government Decision no. 1123 of December 14, 2010. Any additional technical and organizational actions proposed that enhance security, feasibility and accessibility will be

considered an advantage.

Question: Please clarify if SALW e-register and izoteca are two separate projects.

Answer: Yes

Question: Could you please specify if the register will include only arm holders or dealers also?

Answer: The register will include licensed dealers, also.

Question: What file format will be uploaded into the database? Will is store pictures/scanned documents?

Answer: The database will store only reference number of the documents and no pictures/scanned

documents will be uploaded.

Question: Please clarify if the database will be exported or a new one will be created?

Answer: As it was mentioned before, there isn't a SALW database. Creation of this database is the

main objective of this information system.

Question: Could you please indicate if the bidding company should also provide the licenses for the used

technologies (ex: Oracle)?

Answer: Yes

Question: Please state if it is possible to modify some of the terms of the contract mentioned in the Annex II

"General Conditions of Contract".

Answer: The proposal submitted by the bidder shall include a duly singed and stamped Proposal

submission form (Annex IV) that implies that the company understands and agrees with the terms and conditions of the proposed tender. Although some terms related to the copyright

might be changed with prior approval of the UNDP HQ.
