**«Strengthening National Capacities to Protect the Most Vulnerable  
from Torture in Moldova» Project**  
announces an Expression of Interest for  
**GRANTS PROGRAMME (GP-2014: Monitoring)**  
**for Civil Society, April 2014**

The Project «**Strengthening National Capacities to Protect the Most Vulnerable from Torture in Moldova**» is funded by the European Union and co-funded and implemented by the United Nations Development Programme in Moldova in consultations with the Office of the UN High Commissioner for Human Rights, the East Europe Foundation and the Soros Foundation – Moldova. The goal of this Project is to contribute to the prevention of torture and fighting against impunity on the whole territory of the Republic of Moldova, including Transnistrian region, especially in respect of the most vulnerable women and men with psycho-social and intellectual disabilities in mental health facilities. The Project also aims at raising capacities of civil society organisations (CSOs) in monitoring and reporting on the implementation of national anti-torture related strategies, plans and application of legislation.

In order to meet this goal the «Strengthening National Capacities to Protect the Most Vulnerable from Torture in Moldova» Project announces an **Expression of Interest for Grant opened for the coalitions of NGOs** (two or more NGOs) registered in the Republic of Moldova, including Transnistrian region. A project approved for funding should be implemented **from June 2014 to November 2015** (implementation period should be minimum 12 months).

**Project proposals should focus on the monitoring and reporting on the implementation of national anti-torture strategies, plans, legislation and its application.** The monitoring and reporting project proposals should cover at least the implementation of the anti-torture measures planned within National Human Rights Action Plan for 2011-2014 (NHRAP)<sup>1</sup> and Justice Sector Reform Strategy 2011-2016 (JSRS),<sup>2</sup> relevant Universal Periodic Review recommendations for Moldova (UPR), national anti-torture legislation, including the amendments introduced on 8 November 2012 with the Law Nr. 252,<sup>3</sup> practices of the application of the legislation and the prosecution of acts of torture. Project proposals should also include monitoring of relevant international commitments and shadow reporting on the concluding observations of the UN Human Rights Committee (UN HRC)<sup>4</sup> and of the UN Committee against Torture (UN CAT),<sup>5</sup> and on the implementation of relevant UPR recommendations for the Republic of Moldova.<sup>6</sup> In addition to this, the coalition of NGOs should also contribute to the increased and/or strengthened NGOs participation in the NHRAP and JSRS implementation and build a wider local ownership among the NGOs over the reforms.

Successful proposals should also thematically **prioritise covering the issue of torture against women and men with psycho-social and intellectual disabilities in mental health facilities.** The applicants are advised to study the Report A/HRC/22/53<sup>7</sup> as of 1 February 2013 released by Mr. Juan Mendez, the UN Special Rapporteur of torture, which serves as a basis for the understanding of torture in mental and other health facilities, and are encouraged to draft their project proposals based on the issues covered in the Report. Torture in psychiatric hospitals and neurological internats (care homes), is an emerging issue in Moldova and more information about the situation in this sphere can be found in the reports of the Parliamentary Advocates<sup>8</sup> and the Pilot Ombudsperson in Psychiatric Institutions.<sup>9</sup>

Applicants should demonstrate how **gender and minorities (national, ethnic, linguistic, religious etc.) mainstreaming is ensured throughout the project proposal**. This could be done through, but not limited to, the involvement of both women and men, as well as persons belonging to minorities, into the management/implementation of the proposed project, ensuring that women, men and persons belonging to minorities will be planned beneficiaries of the project, raising gender and minority related aspects within the issues covered by the project proposal (for example, prosecutors inaction in cases of sexual abuse of women in psychiatric facilities amounting to torture, involuntary abortions/sterilisation of persons of specific ethnicity in psychiatric facilities, lack of informed consent for medical treatment and medication in preferred language etc.), cooperation with NGOs of persons belonging to minorities for the purposes of project implementation etc.

At least four intermediary and/or thematic reports and one final monitoring report should be produced by the coalition of NGOs within the selected project. And at least two monitoring reports should be drafted and published on the implementation of national anti-torture legislation and the law enforcement practices. The coalition of NGOs should also produce further recommendations for the implementation of the planned actions, effective application of the anti-torture legislation, and will advocate for their realization.

The coalition of NGOs should also ensure visibility for the donors – EU and UNDP – and for the «Strengthening National Capacities to Protect the Most Vulnerable from Torture in Moldova» Project.

Representatives of the coalition of NGOs will be invited to the training activities related to the issue of prevention and combating of torture in mental health facilities, organised within the «Strengthening National Capacities to Protect the Most Vulnerable from Torture in Moldova» Project.

Within this Expression of Interest, one project will be selected and a grant up to **39,000 USD** will be provided for its implementation. Original and innovative project proposals will have priority.

The rules and procedures that will guide the submission, selection and implementation of projects can be found in the **Applicant's Guidelines\***.

**The application package should contain the following documents:**

- Application Form\* (which will include the budget and activities timeline), filled in Romanian, Russian or English. Handwritten Application Forms will not be accepted;
- Copy of the registration certificate to prove that the organization is a registered legal entity;
- Copy of the Statute of the organization;
- Declaration on working within the coalition for the purposes of the project signed and stamped by parties;
- CVs of Project Manager, accountant and key staff, involved in project's implementation;
- CVs of experts and their written consent to be involved in the activities of the project;
- To the extent possible, a brief overview of the activities of the organization (including, if applicable, recommendation letters from other donors, developed materials: researches, strategies, training aids, newsletters, brochures; any other relevant materials/information: newspaper articles, audio/video clips, photo reports from events, etc.);
- Other relevant materials to increase credibility of the Applicant for the donor and to complement the project justification.
