- Q.1. Participants need to make their quotation in USD, are we also allowed offering in Euro's?
- A.1. Preferred currency of quotations is USD.
- Q.2. Item 1 Windows 7 Professional, 64 bit, English. Do you approach the proposal with the latest software product Windows 8.1 Pro or Windows 10 Pro, with possible downgrade to Windows 7 Pro?
- A.2. The request is for Windows 7 Professional, 64 bit, English.
- Q.3. Item 2 Office Home and Student 2013, English. We would like to draw your attention that Microsoft authorizes to use this only for educational purposes and / or for home use. In connection with the above we want to clarify whether you really want to buy this software because its final destination on the basis of the tender documentation does not meet the above criteria?
- A.3. The revised requirement is as follows: Office Home and Business 2013, English. The RfQ15/01122 will be amended to reflect this requirement.
- Q.4. Item 5 Bit Defender Internet Security 2014-2015, subscription 1 year, English. Please note that at the moment in the market there are many alternative software with similar functionality and purpose. Will the proposal has been rejected in the case of the provision of prices of similar software from another vendor?
